**SECTION D Terms and Conditions**

1. **Shirt printing:** One (1), two (2) and five (5) year sponsorship agreements will provide for the basic printing of the sponsors name or name as agreed to with the sponsor, in appropriate lettering on the front of team shirts. This will be up to a maximum of sixteen (16) shirts per sponsored team.
2. **Logos and specialised printing:** Any variation of basic printing of letters on the team shirts in regards to specific logo, emblem or badge etc, will be done at the sponsors cost. The club or the sponsor can agree to explore avenues to find the most economical method of printing.
3. **Payments:** All sponsorship payments agreed to under this agreement will be made to the Brindabella Blues Football Club Inc. within 28 days from the date of this agreement. This is to allow for ordering and printing arrangements to be organised. Should the sponsor decide to change the name, logo, emblem or badge design etc after the initial design is submitted to the printer, this additional cost will be borne by the sponsor.
4. **Refunds:** No refunds will be made to the sponsor in the event of cessation or bankruptcy of the sponsor, the club or termination of the sponsored team. In the event of the folding of the sponsored team then the sponsorship can be transferred to another appropriate team within the club on agreement between the club and the sponsor.
5. **Visibility:** The team shirts with the sponsors name, logo, emblem or badge etc will be worn at all official matches, which the team is involved in. This may include season competition and roo ball matches, Kanga Cup matches, club representative matches in which the club is involved and approved Brindabella Blues Football Club Inc functions. The sponsor agrees for their name, logo, emblem or badge etc to be visible on the shirts, to be visible on official and promotional material and to be mentioned should the players or team be publicised in any way.
6. **Ownership:** The shirts with the sponsors name, logo, emblem or badge design etc will remain the property of the Brindabella Blues Football Club Inc. The existing sponsor under this agreement will be given first preference to renewing the sponsorship term of the nominated team under this agreement. This shall be formalised under approval by the Management Committee of the Brindabella Blues Football Inc.
7. **Completion of agreement:** If after the completion of the agreed term of sponsorship, the sponsor does not wish or show intention within a reasonable time, to renew this sponsorship agreement then the sponsors name will be removed from the team shirts.
8. **Team photographs:** The sponsor will receive a team photograph as soon as one becomes available. The sponsors name, logo, emblem or badge etc will be clearly visible in the team photograph.
9. **Support:** The sponsor or representatives of the sponsor are welcome to attend all matches and activities involved with the Brindabella Blues Football Club Inc. The sponsor or representatives of the sponsor will not have any direct say of the management of the sponsored team and/or coaching methods. The sponsor is welcome to offer constructive comments in the teams performance and activities.
